## Equine Event Stall Rental and Stopover Policy and Charges

We would like to welcome you to Valkyrie’s Haven and are happy to share our facility with you.

**Each equine must have current (within 1 year) negative Coggins on file before or at arrival before your equine unloads. Each equine from outside of KY must have a current (within 30 days) health certificate executed by a licensed veterinarian. Equines should be current on their vaccines. Everyone staying or handling equines at this facility must sign a waiver.**

***Please fill out the stall card with information and contacts for your equine in case of emergency.***

### **Stop Over Stall Rental – \$50 per day Stays of one night are considered Stop Over**

VH staff will care for your equine as needed; stall cleaning, water refilling. We will strip the stall on departure.

Blanketing/fly masks, turnout or dry lot included. Additional needs such as hand walking or medications or wound treatments must be agreed on in advance and fees discussed.

### **Stall Rental Self Care – \$50 One Night Stay \$30 per day/night per equine 2 or more days (no stall sharing)**

12 x 12 stall First bag shavings included. Additional shavings are available @ \$10 per bag.

Each stall has 2 large water buckets. We have grass hay available for purchase \$7/ #50 bale.

It is understood that the owner will do daily care of the equine. Manure picks/buckets provided for use – dump manure in the dumpster behind the equipment barn. Turnout or dry lot can be arranged.

On the last day strip the stall and put manure/shavings in dumpster. **Unstripped stalls will incur a \$20 charge.**

**Note: If your equine has dangerous or destructive behaviors it is your responsibility to notify VH in advance. Excessive damage to property may incur costs you will be responsible for.**

## Release of Liability for Equine Activities

Risks of engaging in equine activities" means those dangers of conditions that are an integral part of equine activities, including, but not limited to:

- (1) The propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them.
- (2) The unpredictability of an equine's reaction to sounds, sudden movement, and unfamiliar objects, persons, other animals, or other things.
- (3) Certain hazards such as surface and subsurface conditions.
- (4) Collisions with other equines or objects.
- (5) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.

"Participant" means any person, whether amateur or professional, who engages in an equine activity, whether or not a fee is paid to participate in the equine activity. Engages in an equine activity" means riding, training, assisting in medical treatment of, driving, or being a passenger upon an equine, whether mounted or unmounted, assisting a participant, spectating or otherwise associating with the premises or enterprise.

The Undersigned, wishing to engage in an Equine Activity, recognizes the inherent risk of being a participant. As such they take responsibility and do not hold the owner/sponsor/director liable for the injury or death of any person involved in equine activities resulting from the inherent risks of equine activities as defined by the law.

The undersigned does hereby agree to hold harmless and indemnify Leslye Sandberg and Valkyries Haven, LLC and Valkyrie Properties, LLC, and their assigns; and further release them from any liability or responsibility for accident, damage, injury, death or illness to the Undersigned or any minor of the Undersigned or to any family member or spectator accompanying the Undersigned or Undersigned minor on the premises of Valkyries Haven or Valkyrie Properties, Paris, KY or while engaging in a related equine activity on or off the premises.

By my signature below, I acknowledge that I assume full responsibility for my safety and understand and appreciate the risks involved in riding/driving a horse. I understand that by executing this agreement, I waive any right I have to hold the above parties liable under any theory of liability for any injuries or other damages I may suffer as a result of my equine activity. I also acknowledge that the releases and waivers I am hereby executing shall be binding upon my heirs and representatives as well as me. I further understand that the above entity makes no representations, nor express or implied warranties, as to the quality and character of the horse and equipment furnished.
