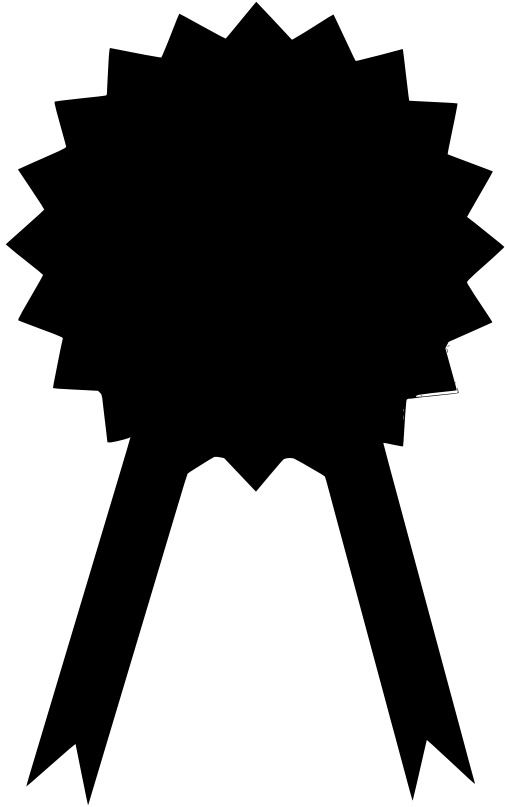

Important Information for Short Format Event Competitors

- **Marathon attire (no shorts) is acceptable in both dressage and cones**
- **Helmets must be worn during marathon and cones, and it is strongly suggested to wear helmets in all warmup arenas.**
- **Back Protectors must be worn on marathon.**
- **Officials, Veterinarian, Farrier contact phone numbers are posted at show office and barn aisles**
- **Pneumatic Tires are permitted in all divisions**
- **In the Beginner and Training divisions at Short Format Driving Events, verbal outside assistance is allowed in any competition phase, including dressage. The groom or and outside assistant standing by the arena may call out the test for Beginner and Training Level classes without penalty. Electronic communication devices may also be used if only one earphone is used at a time while on the carriage.**
- **At Short Format Driving Events with a modified marathon, the whole course must be open for inspection by athletes at 12:00 pm (noon) the day before the scheduled start.**
- **At Short Format Driving Events, in the modified marathon, an athlete who fails to pass through a CTF in the published sequence and direction will incur 5 penalties per error NO Elimination.**

Veterinary and Health Requirements: Flu and Rhino (EHV1 & EHV4 within 6 months of show date per GR844 and Coggins within 1 year of show date. All out of state horses must provide a health certificate within 30 days.

We will have a Vet on Call for Competition setup to take down and Vet on Site for Marathons Contact information on display in Office and posted at Stabling

ANIMAL WELFARE: WE require that all horses be treated with kindness, respect and compassion, and should never be subject to mistreatment. Owners, trainers, riders, and grooms or their agents must use reasonable care in the handling and treatment of their horses whether owned or placed in their care for competition or for any other purpose. At all times, while the horse is on the show grounds, we will provide for the continuous well-being of the horse. No excessive use of the whip will be tolerated. The well-being of the horse must be considered above the demands of the breeders, trainers, riders, owners, dealers, organizers, sponsors or officials. IN THE EVENT OF AN ACUTE AND SERIOUS INJURY TO OR ILLNESS OF A HORSE ON COMPETITION GROUNDS WHEN THE OWNER OR TRAINER OF THE HORSE OR AGENT OF THE OWNER IS NOT PRESENT, AFTER REASONABLE EFFORT TO CONTACT THAT INDIVIDUAL HAS BEEN MADE, COMPETITION MANAGEMENT IN CONSULTATION WITH A LICENSED EQUINE VETERINARIAN, MAY AUTHORIZE THE PROVISION OF EMERGENCY VETERINARY TREATMENT OF THE HORSE. IF COMPETITION MANAGEMENT SO AUTHORIZES TREATMENT UNDER THE PROVISIONS OF THIS RULE, COMPETITION MANAGEMENT AND VETERINARIAN ARE NOT LIABLE FOR ANY RESULTING COSTS, DAMAGES, LOSSES, CLAIM OR ACTIONS ARISING DIRECTLY OR INDIRECTLY FROM THE TREATMENT OF THE HORSE.

Grounds/Haul In Fee: \$75 per entry Arrange with OC in advance

Drug Fee: USEF Entries \$23/horse

Show Pass Fee: Not a USEF Member? \$45 fee for **ALL** non-USEF members. DO NOT include this fee with your entry fee. This **MUST** be done online. Go to [USEF.org/show pass](http://USEF.org/show_pass) for an ID# to submit with entry. Any rider, handler, driver, or owner are limited to one Show Pass purchase annually Dec 1-Nov 30. USEF Show Pass will be available for purchase by exhibitors online only. Competitions can not accept payment for Show Pass fees. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for Show Pass and must obtain a Senior Competing membership to participate in a USEF licensed competition.

MEMBERSHIP STATEMENT: Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at Modified Level or above, and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competition and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass Fee. Participants in the following classes are exempted from the requirements of this rule: 1) Leadline; 2) Exhibitions; 3) Games and races; 4) classes for 4H members; 5) Walk Trot and Academy Classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF Introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

Dog Policy: All dogs must always be on a leash and under control. Please do not take your dogs to the dressage ring or the cones ring during competition, or take your dog into obstacles. Loose dogs, or dogs dragging a leash, will incur a fine of \$25 for the first offense, \$50 for the second, and will increase by \$25 each time. You will need to come to the show office to pay and to collect your dog.

Camping: On site dry camping allowed at no cost. We do have two actual RV hookup sites \$30 per night which have electrical and water hookup. No black water. First come, payment separately in advance to Valkyrie's Haven. Please let the OC know if you will be camping on site.

Hotels: The closest hotel to the farm is the Best Western 2011 Alverson Drive, Paris, KY – just a couple of miles (2 turns) from the farm. 869-987-0779 Rates are reasonable and the hotel is very clean. They will allow pets for an additional fee. There are several airbnbs in the area as well. And many hotels in Georgetown less than 15 miles away.

Food: Food will be available onsite Friday and Saturday from 7:30 am to mid afternoon with MiMi's Kitchen. They have a variety of fare available and also have soft serve ice cream.

Motor Vehicle Statement: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as parent or guardian or a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management at their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, electric bicycles, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed unsafe use if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device is violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Protective Headgear: Rules for all classes will be pursuant to GR801 and DC 913 relating to protective headgear and for FEI Classes pursuant to Article 928.

Sharps Disposal: Competition Management may fine any individual up to \$100 for improper disposal of needles or other sharp disposable instruments.

Food: There are numerous restaurants and fast food establishments within 2-3 miles in Paris. The Walmart is just around the bend and includes a full grocery as well as hot food to go.

Event: Saturday night is our annual Halloween Party - which is open to all. Competitors (ticket included in entry) and for \$15 additional tickets available for crew and guests. Competitors, volunteers and sponsors are invited to enjoy local barbeque, drinks and desserts. Costumes encouraged and your ticket will serve as a raffle ticket for prizes to be drawn at the dinner.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

Under Kentucky law, a farm animal activity sponsor, farm animal professional, or other person does not have the duty to eliminate all risks of injury of participation in farm animal activities. There are inherent risks of injury that you voluntarily accept if you participate in farm animal activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed “unsafe use” if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Release of Liability for Equine Activities

Risks of engaging in equine activities" means those dangers of conditions that are an integral part of equine activities, including, but not limited to:

- (1) The propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them.
- (2) The unpredictability of an equine's reaction to sounds, sudden movement, and unfamiliar objects, persons, other animals, or other things.
- (3) Certain hazards such as surface and subsurface conditions.
- (4) Collisions with other equines or objects.
- (5) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.

"Participant" means any person, whether amateur or professional, who engages in an equine activity, whether or not a fee is paid to participate in the equine activity. Engages in an equine activity" means riding, training, assisting in medical treatment of, driving, or being a passenger upon an equine, whether mounted or unmounted, assisting a participant, spectating or otherwise associating with the premises or enterprise.

The Undersigned, wishing to engage in an Equine Activity, recognizes the inherent risk of being a participant. As such they take responsibility and do not hold the owner/sponsor/director liable for the injury or death of any person involved in equine activities resulting from the inherent risks of equine activities as defined by the law.

The undersigned does hereby agree to hold harmless and indemnify Leslye Sandberg and Valkyries Haven, LLC and Valkyrie Properties, LLC, and their assigns; and further release them from any liability or responsibility for accident, damage, injury, death or illness to the Undersigned or any minor of the Undersigned or to any family member or spectator accompanying the Undersigned or Undersigned minor on the premises of Valkyries Haven or Valkyrie Properties, Paris, KY or while engaging in a related equine activity on or off the premises.

By my signature below, I acknowledge that I assume full responsibility for my safety and understand and appreciate the risks involved in riding/driving a horse.
